# **Make Loan Payments Electronically!**



In the interest of good stewardship, LCEF accepts loan payments through automated clearinghouse (ACH) transactions. No hassles with writing checks or buying postage stamps. Your loan payments will be sent directly to LCEF—electronically!

#### Using ACH for Loan Payments . . .

- Saves you time.
- Eliminates the possibility of lost checks in the mail.
- Removes the worry of late payments.
- Promotes good stewardship by lowering administrative costs, helping LCEF to pass on these savings through lower loan rates to LCMS churches and schools.

## **Two Automatic Payment Methods:**

Simply complete the authorization form on the reverse side to have the loan payment automatically withdrawn from your local checking account (Option A) or transferred from an LCEF account (Option B). Be sure to sign the form, and for Option A, attach a void check. Mail or fax to LCEF.

## **Manual Payment Method:**

Your organization may transfer the payment each month using LCEF's online *MyAccount* service. Use *MyAccount* with the LCEF StewardAccount\* to maximize efficiency!

#### *MyAccount* from LCEF

LCEF's online financial service offers 24-hour access to your LCEF investments and loans.

- View account history.
- Make payments to your LCEF loan from a StewardAccount or Dedicated/Demand Certificate.
- Transfer funds to and from eligible LCEF investments.
- Choose electronic statement delivery (e-statements).
- Contact LCEF staff via secure email system.

- Limited check writing abilities (first order of checks **free!**).
- VISA<sup>®</sup> Debit Card (optional).
- Monthly statements.
- Electronic funds transfer services.
- Free MyAccount online services, including bill pay and e-statements.
